3. Policy Statement

Quality: Maintain required water quality during procurement, use, treatment, and discharge.

The 4 Rs – Reduce, Recover, Recycle, Reuse – are the foundational pillars of Ye Prayas's circular approach to water management.

4. Policy Implementation

4.1 Stakeholder Engagement

Ye Prayas will identify key internal and external stakeholders including employees, suppliers, municipal bodies, recyclers, NGOs, and local communities to understand water-related expectations and challenges.

We will:

Collaborate with research institutes, equipment suppliers, and sustainability partners for technology adoption.
